As part of my Application for Admission to Practice before the Mille Lacs Band Court of Central Jurisdiction, I consent to have an investigation made as to the information in my application and my fitness to practice before the Court. I agree to provide any further information that may be required in reference to my

application. I understand that the foregoing information will be verified to process my application and that the furnishing of false or incomplete information may result in the denial or forfeiture of admission to practice.

I hereby authorize the Mille Band Court of Central Jurisdiction and the Mille Lacs Band Tribal Police Department or their authorized representatives to conduct a criminal record check through the National Crime Information Center (NCIC), the Federal Bureau of Investigation, or the Bureau of Indian Affairs to obtain any information from my official record concerning any conviction and I consent and authorize the release of such information. The results of the criminal record check shall only be used to determine my suitability to practice before the Court of Central Jurisdiction. I understand that except as otherwise provided above, all information solicited and received for the processing of my application is confidential and limited to official use by the Mille Lacs Band Court of Central Jurisdiction and its authorized representatives.

I hereby release, discharge, and hold harmless the Mille Lacs Band Court of Central Jurisdiction and Mille Lacs Band Tribal Police and its authorized representatives and any persons furnishing information authorized by this release from any and all liability arising out of the furnishing of such information.
