ABOUT THIS GUIDE



I've been especially proud of our achievements together these past four years. In 2016, we stood together after the county revoked our law enforcement agreement, never giving into county demands that we deny our reservation's existence. We fought hard legal and policy battles while Band Members rose

up as New Warriors, fighting together to protect our families against criminals and drug dealers who invaded our reservation. We sued the county, we protested, held smudge walks and ceremonies, and fought in St. Paul and Washington D.C. Finally, our law enforcement agreement was reinstated in 2018. Just weeks ago, history was made when the State announced it agrees with the United States that our reservation boundary was never diminished. Many generations of Band Members dreamed of this day and it finally arrived.

Our platform these next four years is very aggressive. Together, we will continue our progress of improving our facilities, diversifying our economy, and expanding language and culture programs. With zero percent interest home loans, more Band Members are homeowners than ever before. We are leading Indian country with exciting food sovereignty and climate change initiatives, our college graduation rate is growing, Nay Ah Shing is on the way to becoming the immersion school our elders dreamed of, and we are making progress in the battle against addiction.

These next four years, we will increase Band Member employment by 50% with new jobs, hiring policies, and a Band Member salary scale. Elders will continue to be our priority, along with safety and wellness for all. All Band Members currently on the waiting list will have a home within two years, we will partner with local schools to improve educational offerings for our children, and build a leadership initiative to support emerging leaders. Together, we can achieve all this and more.

I am 52 years old I have hunted, fished and gathered within our ceded territory since the age of 15 yrs. Old. So you could say I've practiced protecting our treaty rights for 37 years. As a young man growing up, coming with my mother (Martha Davis) niimiiiding in Ahzhiimoog to pray at big drum ceremonies in all three districts but mostly ahzhiimoog but also attended college at Mpls Comm. College I'm currently putting together a bustle to become a traditional dancer but was a Grass dancer for 10 yrs in Contest pow-wows. I was a golden Gloves boxer for 17 yrs and was 5 time National Indian boxing Champion. I participated with the Indigenous Games as a boxer and coached the 19-21 age mens basketball team and won the Gold medal. I am also a published poet you can find my poem in a book in the library of congress called between the raindrops; the title "Modern Warrior."

I was a senior case manager for a non-profit organization in minneapolis I've volunteered at the four winds school and was later hired as a para-professional/drum co-ordinator all for Native youth and families. I moved back home in 1999 and was hired at the hinckley casino and learned how to deal black Jack for a year; but soon realized I needed more involvment so I moved to construction. There I started helping build different structures alongside other band members both men and

women with an extensive list to include my help as a carpenter from 2002-2015 the hotel expansions in Mille lacs and Hinckley the Assisted living Complex in Dist. III the Marathon gas station in Dist. III the Gateway clinic in DIII the parking ramp, and Industrial laundry in District I. Enough about me but my slogan comes from a interpretation of my name and that is "protecting our spirit of tomorrow" first to change the direction that of our government. Because ours is the same as the United States.

Carl Marx once said to have true communism first you must take the peoples land rights, break down the family unit and also take there religion. If that sounds familiar your right. These safety improvements will improve our overall pride in our community and help create jobs for our people outside of the Casino and MLCV.

I would like to introduce a bill that would get funding to teach our culture and language at Onamia schools where over half the population is indigenous. As well as continuing to make strides to incorporate our language into our everyday lives. I would improve communication with, as well as the reliability of, the D1 office. My door will always be open.

We need to build a community that our

children and families can thrive in and be proud of. We need to create a strong foundation for our young families to help them become strong and resilient.

I have dedicated my life to serve the people. I bring integrity, honor and dignity to any position I hold. I will be honest and truthful in my decision making as your representative.

I have a bachelor's degree from the College of St. Scholastica. I have worked in tribal government for 20+ years, off and on since the age of 14. My education and work experience has helped me to understand the various issues impacting our community. I will use this knowledge to create positive change and make our future brighter for the next generations.

Our Ojibwe language and culture is the backbone to our survival. The top priority I would really like to create is a Cultural Preservation Endowment fund to support all cultural programming for our future generations. Funding for cultural preservation should not be fought over every two years during the biennium budget. This fund would support the education and cultural programs for our children and families. Our Ojibwe Immersion classrooms and teachers need to be funded through the 12th grade. Wouldn't it be awesome to have our children be fluent Ojibwe speakers!

As a Nay Ah Shing graduate myself, I

support the Education program also. All my grandchildren attend Wewinabe, Abinoojiiyag and the Niigaan program. The teachers are dedicated and care for our children. The schools teach our children our Ojibwe values and beliefs.

Important issues that need to be addressed immediately are:

- Homelessness in our community
- Lack of Long Term Care services for our elders
- Boarded housing in our community
- Lack of continuation of Ojibwe immersion classrooms beyond 1st grade
- Lack of support for our people in recovery
- Lack of family preservation efforts for our children
- Lack of public transportation
- Unnecessary taxation on our per capita payments
- Lack of communication on local issues in our community

We can work together to figure out solutions that we can implement!
