#### CERTIFICATE OF CORRECTNESS

- WHEREAS, on January 23, 2014, the Mille Lacs Band of Ojibwe Band Assembly ("Band Assembly") approved, and the Chief Executive signed into law, Ordinance 18-14, providing for the background and investigations for employment and election purposes of the Non-Removable Mille Lacs Band of Chippewa Indians and amending subchapter II of Title 24 (Department of Justice) of the Mille Lacs Band Statutes ("MLBS"); and
- WHEREAS, pursuant to 4 MLBS § 18(e), the Solicitor General is responsible to "certify to the ordinances of Band government and codify said ordinances into Band Statutes[;]" and
- WHEREAS, Band statutes do not currently provide any additional guidelines or requirements on how Band ordinances should be codified into Band statutes;" and
- WHEREAS, according to MINN. STAT. 3C.11 (2019), the State of Minnesota Revisor's Office issues certificates of correctness after comparing any amended sections of state statutes with previous editions as a method of ensuring that the law is properly reflected in statutes available to the public;

#### Ordinance 18-14

An Ordinance amending Subchapter II entitled "Department of Justice" of Title 24 of the Mille Lacs Band Statutes Annotated to authorize the Solicitor General to perform background investigations for employment and election purposes.

The District I Representative introduced the following Bill on the 23<sup>rd</sup> day of January, 2014.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of amending Subchapter II entitled "Department of Justice" of Title 24 of the Mille Lacs Band Statutes Annotated to authorize and empower the Solicitor General to perform background investigations for employment and election purposes.

#### Title I

Section 1: Section 1054 (Powers and duties of Solicitor General) in Subchapter II (Department of Justice) of Title 24 is hereby amended to add (j) as follows:

(j) The Solicitor General is authorized to perform background investigations for purposes of employment and election purposes.
