## Band Assembly Weekly Update: Week of September 28-October 2, 2020

- **Formal Notification** dated September 25, 2020 from Joseph Nayquonabe, Commissioner of Corporate Affairs, of FY2020, Capital Projects that reads as follows:

"Please accept this letter as a formal notification that we intend to open FY2020 capital projects. Per the revenue ordinance we must provide notice at least ten (10) business days before expending the money on a project equal to or exceeding \$25,000 and less than \$250,000. If the Band Assembly fails to stay the project within ten (10) business days after receiving notice, then Mille Lacs Corporate Ventures may expend money on the project."
