Band Assembly Weekly Update: Week of November 2-6, 2020

Tuesday, November 3, 2020: Legislative hosted a Pre-Band Assembly meeting to discuss the agenda items. There was discussion of Reports and Presentations by Brendan Fairbanks – Donation request for University of Minnesota, Ojibwe Immersion House and Melissa "Baabiitaw" Boyd– Suspension of Grievance Committee, Early Elder Retirement Option. Unfinished business Nomination TERO, Resolution from leasing of Trust Lands, and 3 MLCV Bills. New Business Bill – Leasing of Trust Lands (HEARTH Act), Bill – supplemental appropriation for HHS, Natural Resources, and Education, 2 CMD Contracts, HHS Contract, Judicial Contract, Formal Notification from Commissioner of Corporate Affairs, Joseph Nayquonabe, and 8 MLCV Formal Requests FY2021 Capital Projects.

- c) **Band Assembly Bill 18-04-16-20:** A Bill for Mille Lacs Corporate Ventures ("Corporate Ventures"), a corporate body politic of the Mille Lacs Band of Ojibwe ("Band"), for the purpose of appropriating funds and authorizing expenditures to Corporate Ventures for its operations, and capital and economic development projects for the period beginning October 1, 2019 and ending September 30, 2020.

- d) **Band Assembly Bill 18-04-17-20:** A Bill for Mille Lacs Corporate Ventures ("Corporate Ventures"), a corporate body politic of the Mille Lacs Band of Ojibwe ("Band"), for the purpose of appropriating funds and authorizing expenditures to Corporate Ventures for the operations, and capital and economic development projects of any current or future non-gaming business managed or operated directly or indirectly by Corporate Ventures ("Non-Gaming Businesses") for the period beginning October 1, 2019 and ending September 30, 2020. **Sponsor: District II Representative Tabled 12/10/2019**
- e) **Band Assembly Bill 18-04-18-20:** A Bill for Mille Lacs Corporate Ventures ("Corporate Ventures"), a corporate body politic of the Mille Lacs Band of Ojibwe ("Band"), for the purpose of appropriating funds and authorizing expenditures to Corporate Ventures for the operations, and capital and economic development projects of Grand Casino Hinckley and Grand Casino Mille Lacs ("Casinos") for the period beginning October 1, 2019 and ending September 30, 2020.

- New Business:
- a) **Band Assembly Bill 19-02-04-21:** A Bill of Supplemental Appropriation for the Health & Human Services, Natural Resources and Education Departments for the Fiscal Years ending September 30, 2020 and September 30, 2021.

Sponsor: District III Representative. Bill was introduced and approved.

- b) **Band Assembly Bill 19-02-05-20:** A Bill enacting the Helping Expedite and Advance Responsible Tribal Home Ownership Act, to be known as Leasing of Trust Lands, and numbered in the Mille Lacs Band Statutes as Chapter 7 of Title 21. The Leasing of Trust Lands Code will grant the Band the authority to negotiate and enter into leases without further approvals by the U.S. Secretary of the Interior. Specifically, the Act authorizes the Band to execute agricultural and business leases of Band trust lands for a primary term of 25 years and up to two renewal terms of 25 years each. Leases of Band trust lands for residential, recreational, religious, or educational purposes may be executed for a primary term of up to 75 years. **Sponsor: District I Representative.** Bill was introduced and approved with changes and with a waiver of the formal reading.
- c) **Resolution 19-02-12-21:** A Resolution Approving the Continuance of the Mille Lacs Corporate Ventures, Non-Gaming, and Gaming Fiscal Operations Until December 31, 2020. Resolution was approved with a waiver of the formal reading.
- d) Contract (CMD): A contract addendum #3 for Degerstrom and Sons Construction, LLC to increase the contract for additional repairs needed for the renovation at 2481 and 2489 Evergreen Court in Hinckley. The addendum also extends the contract end date to December 31, 2020. Contract was approved.

- e) Contract (CMD): A contract addendum #1 for Degerstrom and Sons Construction, LLC to extend the contract end date from June 30, 2020 to July 31, 2021 for the residential fire rehab project located at 17687 Ookwemin Loop in Onamia. Contract was approved.
- f) Contract (HHS): A contract for Sage Prairie to develop a chronic pain clinic for the Band and provide patient care 4-6 hours a week at the Ne Ia Shing Clinic. Contract end date is September 30, 2021. Contract was approved.
- g) Contract (Judicial): A contract for the Law Office of Cynthia Miller to provide technical assistance and training for the Guardian Ad Litems. Contract end date is September 30, 2021. Contract was approved.
- h) **Formal Notification** dated October 29, 2020 from Joseph Nayquonabe, Commissioner of Corporate Affairs, of FY2021, Capital Projects that reads as follows:

"Please accept this letter as a formal notification that we intend to open FY2021 capital projects. Per the revenue ordinance we must provide notice at least ten (10) business days before expending the money on a project equal to or exceeding \$25,000 and less than \$250,000. If the Band Assembly fails to stay the project within ten (10) business days after receiving notice, then Mille Lacs Corporate Ventures may expend money on the project."
