Minisinaakwaang Leadership Academy

The grand opening will be held on **Wednesday**, **July 25** starting at 10 a.m. Keynote speaker Dave Anderson, founder of Famous Dave's restaurants, will speak at 11 a.m. Tours of the new state-of-the-art facility will be available throughout the day.

The school will also host its first annual powwow with a grand entry at 4 p.m. Little Otter, Mudd Lake Singers, Whitefish Bay, and Black Bear Crossing are the drum groups that will perform. Pete Gahbow will emcee the event, Lee Staples will serve as the spiritual advisor, and Ricky White will be the arena director.

"My parents are long-term Band employees, and I knew that I also wanted to use my education to serve the Band," said Pete. "The Department of Administration operates programs that impact the lives of Band members and Band employees."

Pete, who earned his finance degree from St. Cloud State University in May 2007, was a full-time student while he worked his way up from Intern to Deputy Assistant in the Chief Executive's Office. Before beginning employment with the Band government in the spring of 2005, he worked for Polaris Industries and the Occupational Development Center in Roseau, Minn.

Pete and his wife Kristina are expecting their first child this September.

Ask Melanie

During the month of June, I held listening circles in each of the three districts and in the urban area. A number of good questions were raised by Band members at these meetings, and I'm in the process of responding personally to each Band member who brought forth an issue or concern. For this column, I want to respond publicly to a few of the questions that other Band members might also be wondering about.

What is the status of the Band Pension Program for Elders?

The pension plan is in the final process of being reviewed by attorneys with expertise in finance and tax matters. For the past three years, 5% of the Band's net revenues have been set aside to fund this plan, which will provide a pension payment to Elders 62 years of age and older. The plan is expected to be finalized by October 2007.

How will changes to the Circle of Health program affect my family and me?

Due to the rising costs of health care, the Band was required to make some tough decisions with regard to eligibility and coverage for family members who are not enrolled Band members. These proposed changes are intended to ensure that Band members do not experience any decrease in the quality of health care. I will be holding listening circles in July to discuss these changes with you. Health professionals will be in attendance and available to answer your questions. In the meantime, if you have

immediate concerns you can contact the Ne-la-Shing Clinic at 320/532-4163.

Does the Band help pay for legal services for individual Band members?

Legal services are provided to Band members at no cost through East Central Minnesota Legal Aid. These attorneys are also available for consultation or referral to Band members living in the urban area. However, the Band does not pay for private attorneys for Band members.

What is the status of economic development efforts in District II and District III?

Commissioner of Corporate Affairs Sarah Oquist will be holding district meetings to discuss current plans and future ideas for economic development projects in each of our communities. If you have a good idea for a business project, please try to attend these meetings and share your perspectives.

Mii gwetch to all Band members who attended and participated in these listening circles. Your ideas and input are very valuable to me. I look forward to seeing you again at future meetings.

Summer 2007 Bonus Checks

Distribution dates and locations

Checks will be distributed to all eligible Mille Lacs Band members on **August 2**, **2007**, at each Band member's home district. This distribution will include all Band members receiving monthly, bimonthly, and three times per year bonus distributions.

All funds for minors will be placed into a trust account at Morgan Stanley Dean Witter. Individuals who have turned 20 years of age since the last bonus payment in April are eligible for payment. You must be 20 years of age by July 6, 2007 without having to submit a General Education Degree (GED) or high school diploma. For Band members who are 18 and 19 years old and who have not received a high school diploma or GED, funds will be placed into a trust account at Morgan Stanley Dean Witter. If you have not previously submitted diploma/degree information for past distributions, you must send in original documents showing proof of completion to the Tribal Enrollments Office at the Mille Lacs Band Government Center, attention Darcie Big Bear. If you have previously presented either of those documents, your August bonus will be included in your trust payment.

Pick-up locations

Elders, handicapped and homebound persons living in District I, II, IIa, III and the Twin Cities urban area can pick up their bonus checks on **August 2**, **2007**. The distribution sites include the District I Assisted Living Unit, the East Lake Community Center, the Isle Chiminising Community Center, the Lake Lena Community Center, and the Urban Office. Hours are 8 a.m.-4:30 p.m.

If you are an Elder or handicapped person, live in Districts I, II, IIa, III, or the Twin Cities, and are unable to travel to your distribution site, please call the contact person below to make arrangements for your check to be delivered to you on August 2, 2007.

Deadline for changing your pick-up site is at noon on **July 20**, **2007**. Any changes after this time will not be valid. Call Darcie Big Bear at 320/532-7440 or Ginny Davis at 320/532-7512 to verify your change. There will be no exceptions.

Checks by certified mail

Those who can't pick up their checks on the dates listed will have their checks sent out by certified mail by **August 6, 2007**, to the address listed with the Tribal Enrollments Office. Your local post office should notify you of the certified mail within 30 days. If you do not receive your

check by September 6, 2007, contact Darcie Big Bear at 800/709-6445, ext. 7440.

Address and name changes

If your address or name has changed since the last bonus, it is very important that you send in your information to the Tribal Enrollments Office. The deadline for address and name changes is noon on **July 20, 2007**. There will be no exceptions.

All returned checks will be held at the government center and will not be sent out again until the Tribal Enrollments Office has received your updated address or name information.

Other important information

- You must show a picture identification to receive your bonus check.
- Bonus checks will only be given to the enrolled Band member to whom the check is made out.
- Bonus checks will be used to pay delinquent Band loans, discretionary loans, or Mille Lacs Band Court of Central Jurisdiction fines if they have not been paid. For loan status, call Pam Boyd at 320/532-7467. For court fines status, call Gilda Burr at 320/532-7400.
- therefore, all Band members who receive a bonus check should report it as income in the year received. You will receive a 1099-MISC form to remind you of how much income you should report on your tax return. Bonus checks should be reported as other income on a Form 1040 filing-line 21.
- If you are receiving public assistance from the county, please contact your caseworker because the bonus may affect the amount you receive. If, based on discussions with your caseworker, you wish to decline receipt of the bonus, please contact Kathy Heyer in the OMB Office at 320/532-7472 or Darcie Big Bear at 320/532-7440 to get a bonus declination form.

Circle of Health Update

Circle of Health sent a letter on June 15, 2007, to all adult Band members regarding proposed changes to the Circle of Health Program. If for some reason you have not received this letter, please contact Circle of Health at 320/532-5358 or 800/491-6106.

The following changes are expected to be effective on September 1, 2007 (unless noted):

- Co-pay and deductible amounts will be paid on covered services for Band members only.
- COBRA coverage will be paid for six months instead of 18 months.
- Private insurance policies will be covered for one year from the effective date.
- Adoption of enrolled Band member children to non-Band member families will follow the Adoption Policy, which will only assist with Band member charges when Circle of Health is the payor of last resort. (This change is effective 7/1/2007).

We are asking all Band members to call or write us with your comments and concerns. The information you provide will be reviewed and summarized at future board meetings.

Circle of Health has already received many phone calls. To answer one of the most popular questions: Yes, Circle of Health will continue to reimburse or pay premium amounts (private or employee) in full whether the Band member or non-Band member holds the policy.

Circle of Health cards

Depending on the outcome of the proposed changes, new Circle of Health cards may be issued, with only eligible Band members' names on them. If you have not filled out an annual enrollment and consent of release of information form this year, our office may not be aware if your dependants are enrolled Band members, in which case their names will not be printed on the new cards.

Nay Ah Shing American Indian Business Leaders Chapters Formally Recognized by National Organization

The national American Indian **Business Leaders (AIBL)** organization accepted two individual AIBL chapters at Nay Ah Shing Schools – one at the high school and one at the middle school. AIBL is a nonprofit student-based organization, which originated at the University of Montana's campus in Missoula. The original idea for the organization evolved from concerns expressed by many tribal leaders for the need for educated, experienced members to assist with tribal economic development efforts. AIBL puts emphasis on four main areas: education, experience, leadership and culture. The educational, service and social activities of chapters provide opportunities for members to assist in creating a better social, economic and cultural environment for American Indians. As Nay Ah Shing student Kelly Friend said, "It's not just about making money, it's about learning how to run a business."

During the 2006-2007 school year, the middle school chapter operated a snack bar during the lunch hour, controlled inventory, and balanced the finances. The high school chapter held successful raffles at two powwows in the spring. Students from both chapters spent the week at Ruttger's Sugar Lake Lodge in Grand Rapids and developed a business plan for the upcoming year as part of the Youth Entrepreneurial Summer (YES)

Camp. The plan was completed under the direction of Sharon James and John Gunstad with the Corporate Commission's Small Business Development Program. The students also worked with students from Fond du Lac Tribal and Community College's AIBL chapter, which won national recognition for its business plan this year at the national conference. This is the third year that Nay Ah Shing students have attended a summer program. More information about the YES Camp will be provided in next month's Inaajimowin.

Diabetes Team Update

Public Health screening at August powwow

Have you ever wondered what your blood sugar, oxygen, blood pressure or hemoglobin levels are? Maybe you would like to know about your risk of developing diabetes, or how to prevent the onset of diabetes. Or maybe you just want to unite with other community members in receiving diabetes care education. If so, come join us! It's time to start thinking about the free screenings that will be available at the upcoming powwow again this year for people 21 years of age and older. A blood glucose screening can identify those who have or are at risk for diabetes or pre-diabetes.

Why screen?

The primary reason for screening in a community is to improve the health of an individual. It is estimated that half of all people with diabetes do not know they have diabetes. Diagnosing diabetes early will decrease the likelihood of complications and related conditions, such as a heart attack and stroke. It has even been shown that those with prediabetes, if found early enough, can be reversed or delayed with lifestyle changes, including a healthy diet and exercise. Type 2 diabetes is an epidemic right now. Many tribes across the nation are using powwows as an opportunity to have a diabetes screening.

When?

The free screenings will be provided by the Public Health Department's Diabetes Team and will be available at the Mille Lacs Powwow on Saturday, August 18, from 9 a.m. to 4 p.m. Door prizes, including pedometers for measuring walking steps and free glucometers will be given away.

Your participation will help to make this upcoming event a huge success and will help to identify and prevent diabetes in our community. If you have any questions about the screening or diabetes in general, please call me at 320/532-4163, ext. 2527.

Healthy Heart update

Band Member Teaches Others About Purple Martins

On June 23, purple martin enthusiasts gathered for the 2007 Minnesota MartinFest in Rice, Minn., including Mille Lacs Band Department of Natural Resources (DNR) Wildlife Biologist Kelly Applegate. The Mille Lacs Band donated \$300 to help with the festival.

Kelly has participated in this annual event for the past four years; this year he gave a presentation on building and maintaining purple martin houses and trapping invasive species. Demonstrations on how to check purple martin nests and discussions on purple martin conservation were also part of the festival.

Purple martins are the largest members of the swallow family and typically live in human-made bird houses. In generations past, Mille Lacs Band members hung gourds to attract purple martins to make their nests. Not only would this attract purple martins to the area for bird-watching purposes, but the birds also helped to keep hawks and raccoons away from drying meat and animal hides.

Today, Kelly has helped the Band's DNR build six purple martin communities on the reservation, including one at the District I Assisted Living Units and one at Eddy's Resort. All the communities together contain more than 100 purple martin houses – including a mix of wooden bird houses and gourd houses. Kelly has been instrumental in getting these placed on the reservation in order to help increase the purple martin population, which has been declining in recent years (according to the Audubon Society, purple martins have had a 78% decline in population in Minnesota since 1967).

Kelly is responsible for maintaining the purple martin houses, checking on the nests, and removing unwanted species, such as English house sparrows and European starlings, which attack the nests.

"People often come up to me when I'm checking on the purple martin nests and ask about the birds," said Kelly. "I've heard Elders say that they used to see more purple martins around the area when they were younger, and are now seeing them come back."

All of the Band's wooden purple martin houses were made by the DNR and built with white pine from the reservation. Thank you to Robert Lindstrom and Wendell Leecy with the Maintenance Department for their help in building these houses.

Band gets \$500,000 to Start Child Support Enforcement Agency

The grants department has secured a \$500,000 Title IV-D Tribal Child Support Enforcement (TCSE) start-up grant from the Administration for Families and Children (ACF) that will pay for the Band to start its own child support enforcement agency.

Previously, only states could administer a federal child support enforcement agency. Many states, like Minnesota, turn over responsibility for child support enforcement to the counties, who run it through their county attorneys' offices.

By operating its own agency, the Band will be able to access the federal funds that are currently going to the state and counties to administer enforcement. The Band can then use those dollars more effectively. Other tribes who have started their own agencies have seen child support payment collections nearly double during their first year of operation.

Another difference involves in-kind child support payments. The state system does not allow

in-kind payments. An in-kind payment is when something else is offered as payment instead of the usual cash payment that the state requires. If the Band chooses to allow inkind child support payments, a custodial parent and a non-custodial parent can work out arrangements that allow the non-custodial parent to provide things like food, transportation, daycare, house repairs, etc., instead of cash.

Often these forms of payment can be more beneficial to the custodial parent than cash, and can also be beneficial to the non-custodial parent who may be out of work or have other financial difficulties.

In the end, though, it's all about our kids. While nobody likes being forced to make child support payments, nobody likes watching their kids or grandkids live in poverty, either. By forming our own child support agency, we will be able to make our own enforcement rules that will allow us to increase collections, reduce arrears, and care for the kids who can't care for themselves.

The panel, hosted by the Minnesota Board of Aging's Indian Elder division, discussed a variety of topics, including diabetes prevention, home safety, nutrition, and exercise.

Severe weather training at district community meetings

We are also working with the National Weather Service to present severe weather preparedness information at district and urban area community meetings. Following each presentation, we are giving away a National Oceanic and Atmospheric Administration

(NOAA) weather radio.

Educating community members about severe weather is the next step that the Band is taking in its StormReady certification – which is a National Weather Service recognition for communities prepared with action plans for responding to severe weather. As part of the certification, we have also placed NOAA weather radios in all Band facilities in Districts I, II, IIa and III.

Our next presentation will be at the July 12th community meeting in District III.

Emergency Preparedness Training

On July 19, the University of Minnesota's Minnesota Emergency Readiness Education & Training (MERET) program will hold emergency preparedness training at Grand Casino Mille Lacs from 7:30 a.m. to 5 p.m.

Mille Lacs Baths and Birch Bark Canoes

The water is warming up in the big lake and the sun is getting high in the sky...and the tourists are doing their best to look like we always do. I'm even starting to look like a fullblood.

The sun hasn't reached the part of me that remains naturally less pigmented. But everyone should remember, the sun can be harmful if you stay out in it too long, regardless of how dark or light your skin is. These days, the sun doesn't discriminate. Full-blood or not, no matter how dark each of us is naturally, we all have something in common – we're prone to skin cancer.

If you don't use sun block yourself, make sure that your small ones wear a sun block in the SPF 30 range. Why, you ask? As Indians, shouldn't we have natural protection?

We used to, but the rules have changed. Years ago, the sun may not have been as damaging to us. But pollution in the air and a hole in the ozone layer lets more harmful sunrays reach us these days. (I have never actually seen the hole in the ozone layer myself, but I've read enough to know it's there.)

Remember when we were young? Every trip to the beach on the big lake involved one important task – taking a bath. It seemed natural since there was all that water that nobody was using, and we didn't have to worry about the floor getting wet.

By the end of our bath, we were so incredibly clean, in part because of all that sand that stuck to the soap, almost like our own homemade version of Lava soap.

These days our soap is different. Our water is a little different now too; it has things like Zebra mussels and Chinese snails and Eurasian milfoil in it. I don't think any of us tribal members are to blame for this, though some people around these parts try to find a way to blame us for anything that goes wrong.

But when I last checked, all of our tribal ships with ballasts full of water from some far-off international ocean waters were empty before we portaged. Of course, that's after we had to stop and lay on the hot asphalt to warm up from our cool refreshing bath.

So remember this summer, regardless of whether you are out with that high tech boat or your birch bark canoe, make sure that the strange weeds and species that get drug around by people who don't know any better, aren't hanging on your canoe, canoe trailer, or freighter.

Make sure that all of the water that leaked into your canoe leaked back out before you leave the shipping lanes. Don't be afraid to pick up some of the trash that seems to be left behind by our shipping or sportsmen friends. And, especially remember to tell the small ones about how harmful trash left behind can be to the waters that give us life.

Tribal Police Cracking Down on Noise Ordinance

I want to remind Band members about the Band's "Public Nuisance Ordinance" and let you know that moving forward, tribal police officers will be especially strict on enforcing noise laws.

Elders have voiced their concerns about noise at recent community meetings. Noise is a serious issue that not only wakes people up at night, but also raises worries about safety. The noise ordinance is in place to help ensure that our Band neighborhoods are great places to live, where people feel safe and secure in their own homes. Our heightened enforcement efforts are a direct response to people's concerns.

Excessive noise is outlined in Band statutes as follows:

- Loud music: "Any music emitted from any car, house or music player so as to create a disturbance to the neighbors or community members between the hours of 10:00 p.m. and 8:00 a.m." (Statute 302 i.)
- Uncontrolled party: "Any social gathering that creates a

disturbance so as to disrupt the peacefulness of the neighborhood or community due to loud noises and/or fights or other obnoxious behavior." (Statute 302 k.)

Tribal police officers have the authority to enforce the ordinance on all Band lands.

Please do your part by:

- Keeping noise levels down on your property and in your car.
- Telling your children and grandchildren about the noise ordinance and the ramifications of being cited for a noise violation.
 Citations carry the possibility of misdemeanor charges and fines
- Reporting violators to law enforcement. During regular business hours on weekdays, call the tribal police department at 320/532-3430. On weekends or after hours, call Mille Lacs County dispatch toll-free at 888/860-8250.

If we all do our part, we will have fewer violations and more peaceful neighborhoods. Thank you!

Band and Mille Lacs County Officials Meet to Discuss Law Enforcement Agreement

A cooperative law enforcement agreement that has been in place since 1998 was the focus of a June 29 meeting between Band and Mille Lacs County officials.

The Mutual Aid Law
Enforcement Agreement enables
tribal and county police officers
to cooperate with and assist one
another for purposes of providing
law enforcement services
throughout Mille Lacs County
and within the Mille Lacs
Reservation. The Band also has
mutual aid agreements in place
with other counties.

For more than 10 years, the agreement between the Band and Mille Lacs County has worked very well, a sentiment echoed by both Band and County officials. "This agreement is one of the few examples of a good cooperative relationship between the Band and Mille Lacs County," said Tadd Johnson, Mille Lacs Band Special Counsel on Government Affairs.

The Mille Lacs County Attorney's Office recently began raising concerns with regard to how the Band's Solicitor General forwards police reports to the County for prosecution. Solicitor General R.J. Brunkow said, "We are implementing this agreement to protect public safety and the Band's rights."

In an effort to educate County officials and dispel misinformation, Band attorney Marc Slonim led the June 29 discussion to respond to questions and concerns. Slonim is the attorney who successfully litigated the Band's 1837 and 1855 treaty cases.

In a good-faith effort to preserve the agreement, the Band will continue to keep communication lines open with the County. Participants in the meeting agreed that the Band would develop a proposal responding to County concerns. Band attorneys are in the process of drafting that proposal.

Regardless of any action that Mille Lacs County eventually takes, the Band will continue to provide public safety services to Band members within the Mille Lacs Reservation.

Band Leaders Urge Sharing of Nelson Act Claims in Nation's Capitol

Secretary/Treasurer Herb
Weyaus, along with several other
members of the Tribal Executive
Committee of the Minnesota
Chippewa Tribe (MCT), traveled to
Washington, D.C. in June to
oppose H.R. 2306, a bill to divide
the Nelson Act settlement funds.
The MCT opposes the bill,
introduced by Representative
Collin Peterson (D-MN), because it
is contrary to an MCT resolution
passed in 1999.

In 1999, the MCT's Tribal Executive Committee voted (10-2) to allocate the Nelson Act funds equally among the six bands. However, in 2001, the Bureau of Indian Affairs (BIA) recommended that the funds be divided based upon each band's enrollment. The MCT immediately objected and continues to object to the BIA's position. However, without notifying the MCT, the BIA sent a letter to the Congress in April 2007 introducing legislation to make the BIA proposal effective. Representative Peterson, whose district includes the White Earth Reservation, introduced HR 2306 (the BIA's proposal) in May. The White Earth Band has the largest population of any band in the state.

In a May 18 letter to Senators Coleman and Klobuchar, MCT President Norm Deschampe stated: "We urge the Congress to take action to fulfill the federal government's trust responsibility to the Minnesota Chippewa Tribe...the Congress should refer the Minnesota Chippewa Tribe's proposed legislation to the appropriate committees and enact it as soon as possible."

The Mille Lacs Band supports the MCT's position on the equal distribution of funds among the six bands, and Band officials have voiced their support as they visited Senators and members of Congress on Capitol Hill.

"We were out there to make the case that the Congress needs to respect tribal sovereignty and respect the vote the MCT took on this matter," said Herb.

The Nelson Act was enacted in 1889. In 1948 and 1951, the MCT filed complaints before the Indian Claims Commission that: 1) the proceeds from the sale of land and timber on the six reservations of the MCT under the Nelson Act were misspent; and 2) the land and timber taken were sold at less than full value. In 1999, the claims were settled and the MCT recovered \$20 million from the United States. Since then, the funds have collected more than \$6 million in interest.

Housing Department Offers Home Safety Training

Ask Americans where they feel the safest and most will say within their own home. However, unintentional injuries in the home result in nearly 21 million medical visits each year.

To help Band members learn about safety issues in their homes, the Band's Housing Department will offer monthly healthy home safety trainings starting this month. Housing department staff will hold halfday sessions to talk about issues such as indoor air quality, controlling mold problems, preventing carbon monoxide exposure, drinking water analysis, and other topics. - Use a non-slip mat or install strips or decals in bathtubs and showers.

Poisonings

- Keep medicines and household cleaners up high, out of the reach of children.

Multi-Tribal Indian Housing Project Awarded Funds

Band seeking more funds for more projects

The Band is enhancing its reputation once again as the lead developer for a multi-tribal Indian housing project in the Twin Cities that is the first of its kind in the nation. The project is designed to reduce homelessness by helping provide homes to all low-income Indian families in the urban area regardless of tribal membership.

Last year I worked closely with Lindalee Retka, Assistant Executive Director of Housing for the Mille Lacs Band, to put together a winning proposal to secure funds from the Minnesota Housing Finance Agency (MHFA). That award brought \$390,000 to the project, and this year an additional \$500,000 was awarded for this worthy project.

Other grant applications that have recently been submitted and are awaiting awards including a \$150,000 Department of Justice Tribal Courts Assistance Program (TCAP) grant to provide our courts with a court reporting

system and a court case management system. Both of these systems have been sorely needed for a long time. With better organization and management, our courts will be able to handle more cases more professionally.

Also recently submitted and awaiting award is the TCE **Treatment Expansion grant** application. If awarded, this grant will pay for the salary and benefits of three new outpatient treatment case managers. Along with a new treatment model (known as the Matrix) being implemented by the Department of Behavioral Health, these new case managers would vastly improve the Band's efforts to provide outpatient treatment and relapse prevention services. Besides their salary and benefits, the \$1.5 million request will also provide funds for training Behavioral Health staff, for travel and local mileage, and for incentives for participants to stick with their treatment and not drop out of the program.

These are just a few examples of the ways in which outside funding sources can help us reach our goals.

Recipe: Angel Lush With Pineapple Cake

Preparation time

• 15 minutes plus refrigeration

Ingredients

- 1 pkg. (4-serving size) JELL-O Vanilla Flavor Instant Pudding & Pie Filling
- 1 can (20 oz.) crushed pineapple in juice, undrained
- 1 cup thawed Cool Whip Whipped Topping
- 1 pkg. (10 oz.) prepared round angel food cake
- Seasonal berries

Directions

Mix dry pudding mix and pineapple with juice in a medium bowl.

Gently stir in whipped topping. Let stand for five minutes.

Cut cake horizontally into three layers. Place the bottom cake layer (cut side up) on a serving plate.

Spread 1 cup of the pudding mixture onto the cake layer; cover with the middle cake layer. Spread 1 cup of the pudding mixture onto the middle cake layer; top with the remaining cake layer. Spread the cake with the remaining pudding mixture. Refrigerate at least one hour or until ready to serve. Top with your favorite seasonal berries. This recipe serves ten people.
